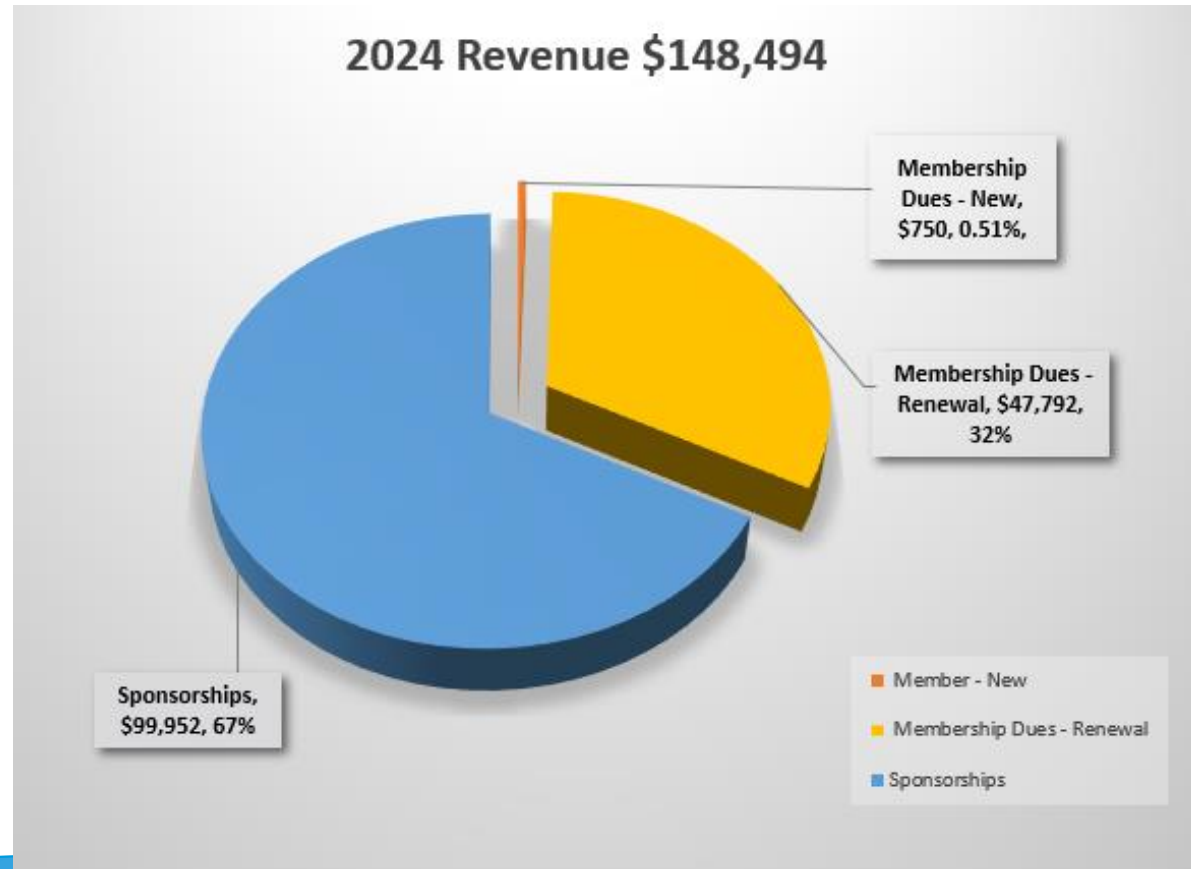

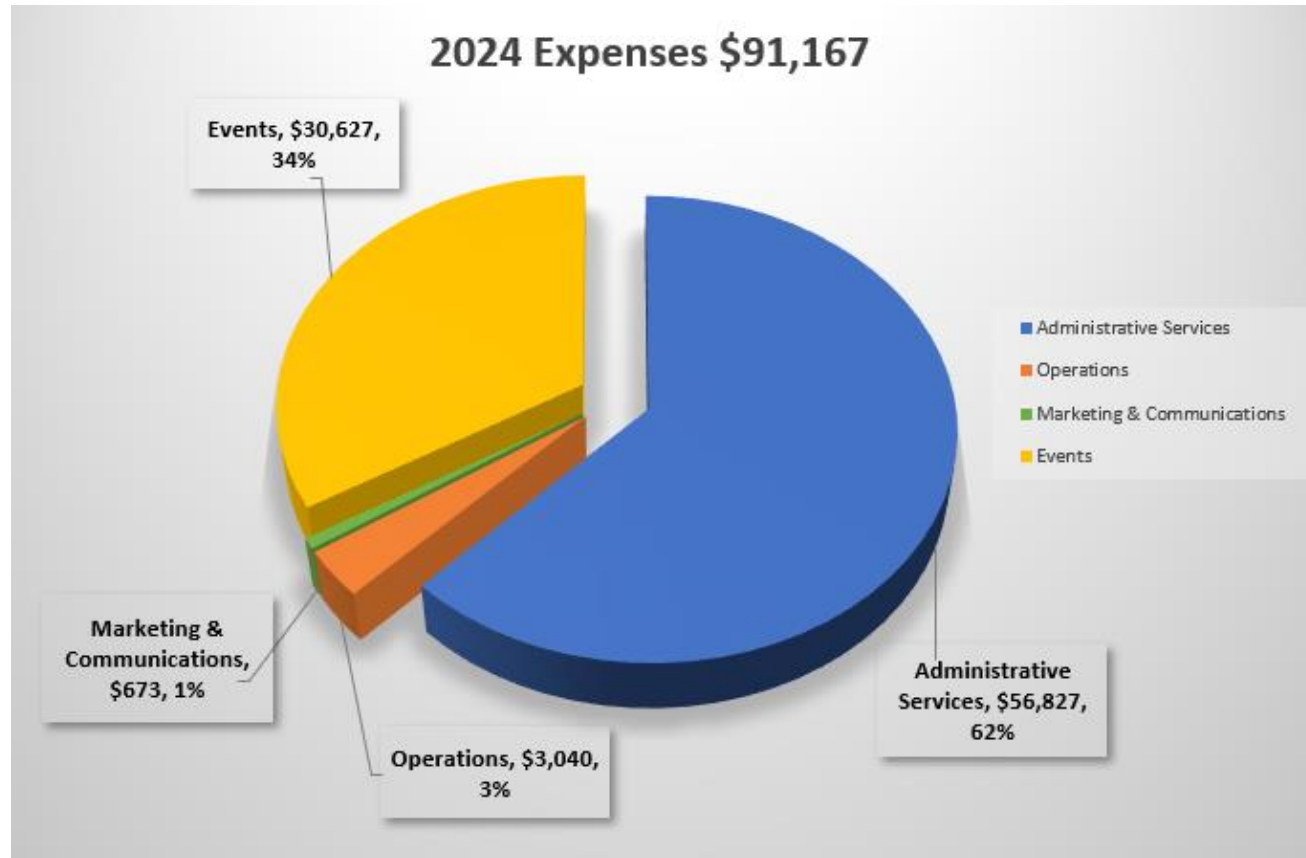

# 2024 Finances Revenue

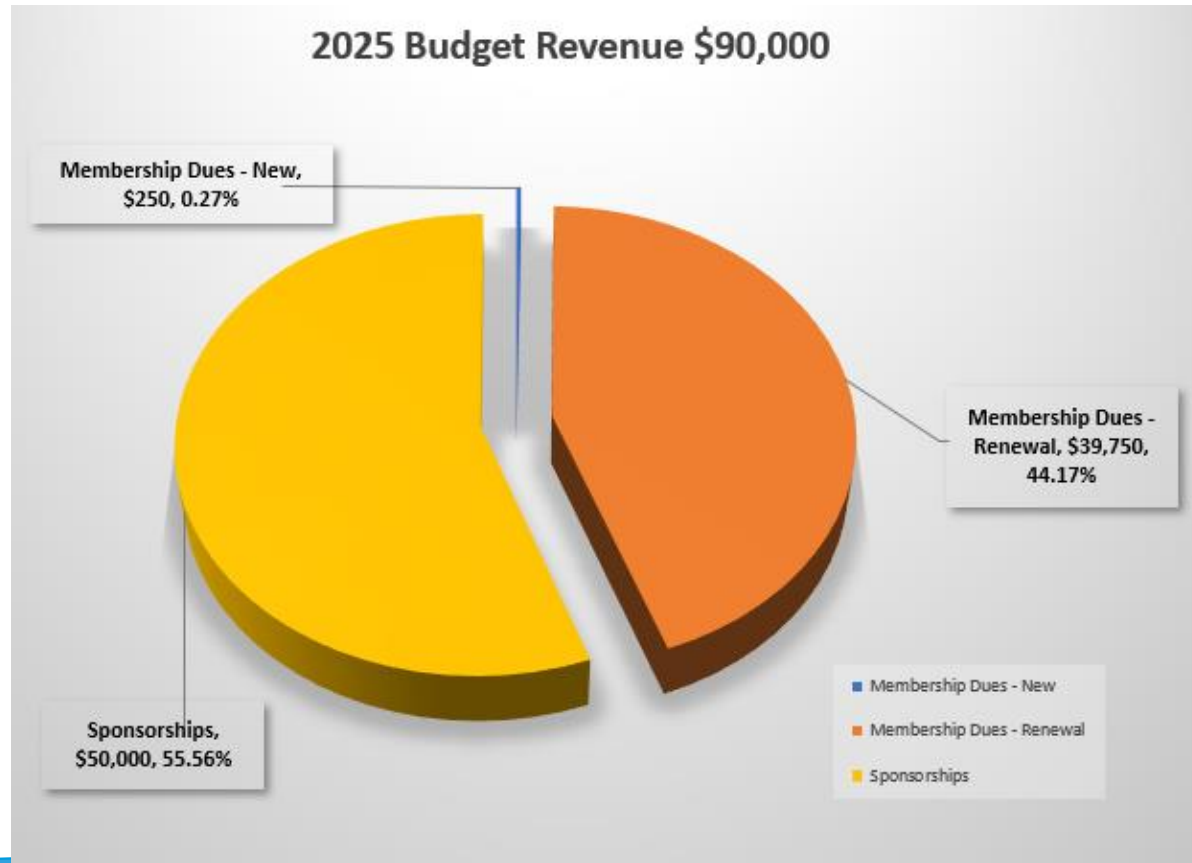




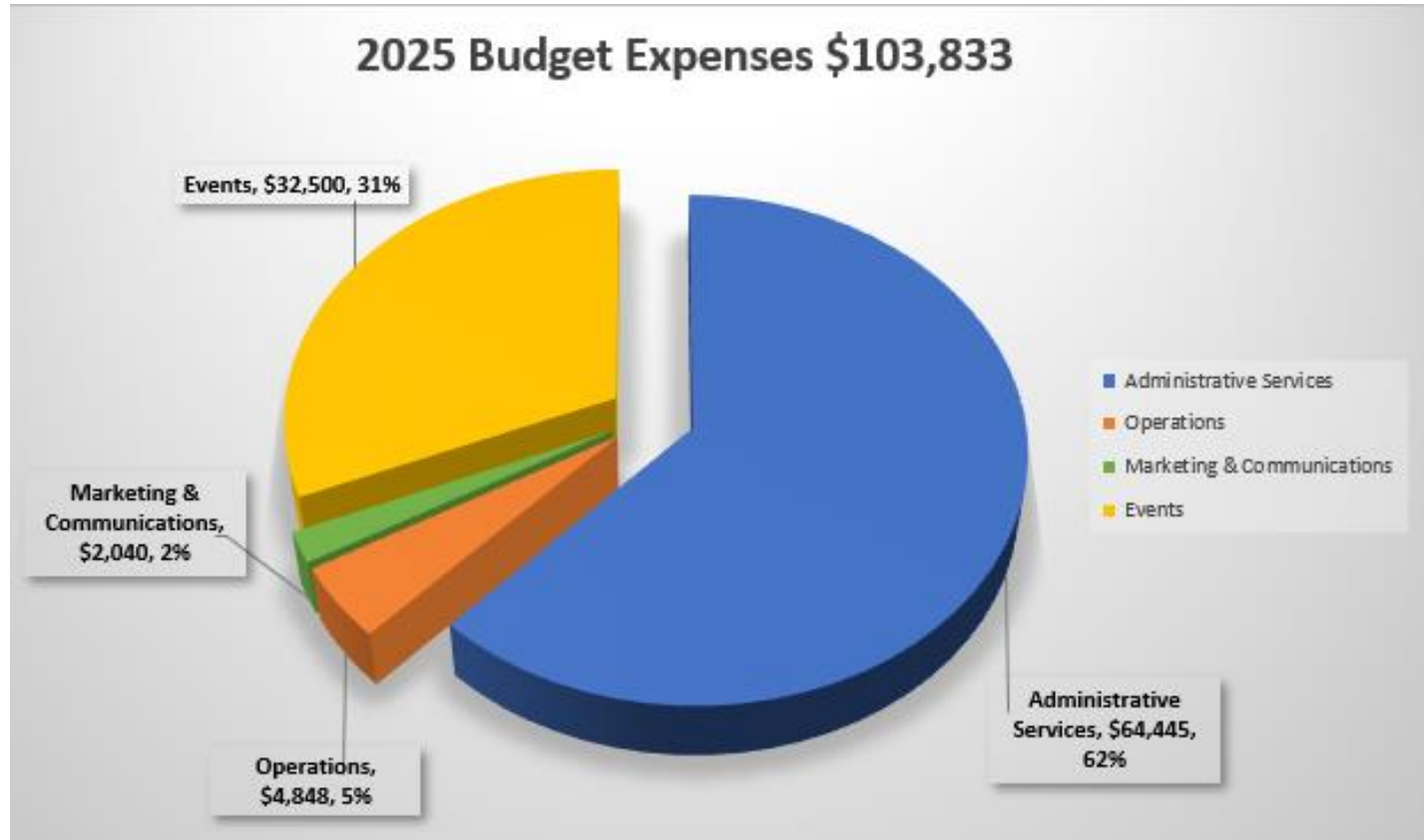
# 2024 Finances Expenses

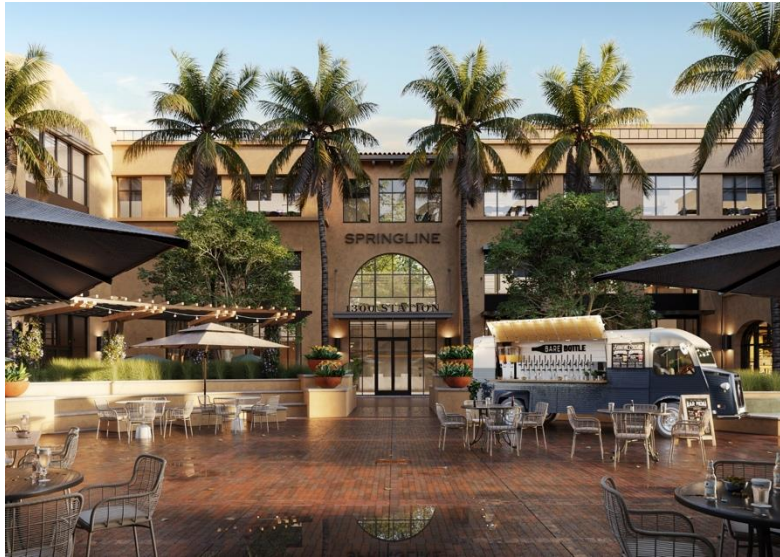
